COMMONWEALTH OF VIRGINIA SALES AND USE TAX CERTIFICATE OF EXEMPTION

For use by a Virginia dealer who purchases tangible personal property for resale, or for lease or rental, or who purchases materials or containers to package tangible personal property for sale

The Virginia Retail Sales and Use Tax Act provides that the Virginia Sales and use tax shall not apply to tangible personal property purchased for resale; that such tax shall not apply to tangible personal property purchased for future use by a person for taxable lease or rental as an established business or part of an established business, or incidental or germane to such business, including a simultaneous purchase and taxable leaseback. The Act provides also that such tax shall not apply to packaging materials such as containers, labels, sacks, cans, boxes, drums or bags if the materials are marketed with a product being sold and become the property of the purchaser.

This Certificate of Exemption may not be used by a using or consuming construction contractor as defined in the Regulations.

The undersigned dealer hereby certifies that all tangible personal property purchased from the above named supplier on and after this date will be purchased for the purpose indicated below, unless otherwise specified on each order, and that this Certificate shall remain in effect until revoked in writing by the Department of Taxation. Check proper box below.

VPPSA Compost Facility Account Procedures

The Virginia Peninsulas Public Service Authority offers accounts for qualified commercial customers at the Compost Facility. Accounts allow customers to use a certified scale to weigh incoming material as opposed to being charged by vehicle and trailer size rates. Accounts also allow customers to bring in incoming yard debris material and purchase mulch, compost, and soil blend products throughout the month to be billed by invoice at the end of the month.

To apply for an account at the VPPSA Compost Facility, the credit application for a business account form must be completed, submitted, and approved by VPPSA. VPPSA will also require a fully completed ST-10 form to be completed for any tax exemptions. Forms are available at the Compost Facility located at 145 Goodwin Neck Road, Yorktown, Virginia 23692 or at www.vppsa.org under the Compost Facility page. Forms can be returned to the Compost Facility or the VPPSA Administration Office at 475 McLaws Circle, Suite 3B, Williamsburg, VA 23185.

A hold s until s property unt holder is poly for an a cacount after a it y oversight VPPSA Compost Facility account holders are expected to pay monthly invoices within 25 days. VPPSA will provide a warning notice to account holders who have not submitted payment within 45 days. At 60 days past due, an account will be placed on hold and the account holder will not be able to bring in yard debris or purchase materials until the account is reconciled. The account can be released from the hold status if it is properly reconciled before 90 days. If an account exceeds 90 days past due, or if an account holder is placed on hold for a second time within a two-year timeframe, their account will be terminated, and the account balance will be sent to collections. If a VPPSA Compost Facility account has been terminated, the customer will not be allowed to apply for an account with VPPSA for a period of one-year. If the customer applies for an account after a period of one-year, the application will be reviewed by the compost facility oversight committee for denial or approval with any special conditions.

VPPSA Compost Facility Account Discount Procedures

The Virginia Peninsulas Public Service Authority (VPPSA) offers discounts to customers who choose to set up an account with VPPSA as an incentive to participate in the program.

VPPSA reserves the right to limit the quantity and type of material that a customer may purchase, to ensure product availability for all customers. VPPSA reserves the right to change or discontinue the account pricing on each commodity as needed; however, regular pricing will be available.

Therefore, account discounts will be made available to those customers who meet the following criteria:

- Must have an approved credit account with VPPSA
- Account must not have any past due billing statements or be in a hold status

Account holders will be given the following discount:

• \$2 off per cubic yard for mulch, soil blend, and compost products

Compost Facility Volume Discount Procedures

The Virginia Peninsulas Public Service Authority (VPPSA) may offer discounts as an incentive to purchase large quantities of materials.

VPPSA reserves the right to limit the quantity and type of material that a customer may purchase, to ensure product availability for all customers. VPPSA reserves the right to discontinue any volume discount pricing at any time; however, regular pricing will be available.

Therefore, volume discounts will be made available to those customers who meet the following criteria:

- Customer must purchase a minimum of 200 cy of a material within a month's timeframe
- Customer must fill out a request form and receive approval by VPPSA before the discount is issued
- It is the responsibility of the customer to ensure they are showing the customer service representative at the compost facility the approved discount request each time they purchase from the facility
- Must have an approved credit account with VPPSA
- Must agree to purchase the quantity as requested in the timeframe approved to receive discount level
- If a customer receives approval for a discount and does not purchase the quantity requested in the timeframe approved, they will not be eligible to receive bulk discounts in the future. VPPSA may terminate a customer account if the customer does not comply with volume discount procedures.
